1. It is a privilege, not a right, to participate in BOLIP Children's/Youth Ministry activities, including but not limited to Sunday Services, Children's Church, Sunday School, cell group meetings, field trips, events, retreats and childcare. This privilege may be revoked at any time, for any reasons, that does not violate Federal, State or Municipal laws, policies, or procedures.

2. The Participant (child) shall comply with the rules and regulations of Activity or Activities, and also comply with instructor ction and direction of BOLIP personnel and/or its agents. The Participant shall generally conduct himself/herself at all times in keeping with standards so as to reflect positively on himself/herself. Failure to meet these obligations may, in the discretion of BOLIP, result in immediate removal from Activity or Activities and a prohibition against any future involvement in Activity or Activities and a prohibition may, in the discretion of BOLIP, result in immediate removal from Activity or Activities. Should the violation of these obligations also result in bodily injury or property damage during Activity or Activities, the Participant's Parent/Legal guardian ("Parent") will (a) pay to restore or to replace any property damaged as a result of the Participant's violation, (b) pay any damages caused to another individual's bodily injury, and (c) defend, protect, and hold harmless BOLIP from such property damage or bodily injury claims.
3. The Participant's parent/legal guardian understands the nature of the Activity or Activities, with the Participant voluntarily desiring to participate in the Activities. On behalf of the minor Participant, the parent/legal guardian does hereby assume all risk of accidental personal injury, sickness, death, damage and expense as a result of participation in recreation and work activities involved therein. All such risks are deemed to be inherent to the Participant's participation in Activity or Activities. BOLIP does not make any warranty or guarantee of safety, although the teachers and/or volunteers of Children's Ministry try to keep participants safe.
4. In consideration of BOLIP allowing the Participant to participate in Children's ministry Activity or Activities (Sunday Services, Children's church, Sunday School, cell group meetings, field trips, events, retreats and childcare) the participant's parent(s)/legal guardian(s) do hereby release, forever discharge and agree to hold harmless BOLIP, its pastors, Board of Directors, administrators, e, teachers, volunteers, and agents (collectively herein the "Church") from any and all liability, claims or demands for accidental personal injury, sickness or death, as well as property damage and expenses, of any nature whatsoever which may be incurred by the undersigned and the Participant while involved in the Children's activities. The parent(s)/legal guardian(s) further hereby agrees to hold harmless and indemnify said Church for any liability sustained by said Church as the result of the negligent, willful or intentional acts of said Participant, including expenses incurred attendant thereto. The parent(s)/legal guardian(s) also, furthermore, understands and agrees that to the fullest extent allowed by law, he/she is waiving and releasing any potential future claim he/she might otherwise have been able to assert against BOLIP, its pastors, Board of Directors, administrators, employees, teachers, volunteers, and agents ("Released Parties") by or on behalf of the Participant or any parent, administrator, executor, trustee, guardian, assignee or family member.
5. The BOLIP Children's Ministry Participant Parent Waiver & Release shall be governed by the laws of the State of Oregon. The BOLIP Children's Ministry Participant Parent Waiver & Release is to be broadly construed to enforce the conditions set forth above, and shall not be construed against the Released Parties solely on the basis that this BOLIP Children's Ministry Participant Parent Waiver & Release was drafted by BOLIP. If any part of this Agreement is deemed invalid or ineffective, all other provisions shall remain in force. No oral modification of this BOLIP Children's Ministry

Participant Waiver & Release, or alleged change or modification of its terms by subsequent conduct or oral statement is allowed. BY SIGNING BELOW: (1) I AM GIVING UP SUBSTANTIAL ACTUAL OR POTENTIAL RIGHTS IN ORDER TO ALLOW MY CHILD TO PARTICIPATE IN A ACTIVITY OR ACTIVITIES; (2) I HAVE SIGNED THIS BOLIP NE JUNIORS FELLOWSHIP MINISTRY PARTICIPANT PARENT WAIVER & RELEASE WITHOUT ANY INDUCEMENT OR ASSURANCE OF ANY NATURE, AND WITH FULL APPRECIATION OF THE RISK INHERENT IN ACTIVITY OR ACTIVITIES, (3) I HAVE NO QUESTION REGARDING THE SCOPE OR INTENT OF THIS AGREEMENT; AND IF I HAD A QUESTION OR QUESTIONS, THOSE QUESTION OR QUESTIONS HAVE BEEN ANSWERED TO MY SATISFACTION; (4) I HAVE THE RIGHT AND AUTHORITY TO ENTER IN NE JUNIORS FELLOWSHIP MINISTRY PARTICIPANT PARENT WAIVER & RELEASE, AND TO BIND MYSELF, PERSONAL REPRESENTATIVE, ASSIGN, HEIR, TRUSTEE, OR GUARDIAN TO THE TERMS OF THIS AGREEMENT.
